



**Free Early Education Entitlement – 3years+
Nightingale Nursery
Summer Term 2026**

We are delighted to be offering the Free Early Education entitlement for children from the term after their third birthday.

As Nightingale Nursery offers year-round provision, **we are offering the hours stretched over 48 weeks** (up to 12 hours per week). Where the 'stretched offer' leads to children exceeding their free early education hours, you will be given the option of removing your child from the setting or paying for the additional hours.

Our sessions are from 8.30am to 5.30pm, with optional wrap-around care from 7.30am and until 6.30pm. We do not provide part days as we feel educationally and operationally these are not in the best interests of the children or the Nursery setting.

We only offer the universal Free Early Education (FEE) Funding, we do not offer the extended entitlement. Please find enclosed the fee schedule showing the fees payable to Ashford School for the provision of nursery education during Summer Term 26 at Nightingale Nursery. The schedule reflects the total payable for the period 20 April – 24 August 2026 (inclusive) in line with the KCC calendar. Charges can also be found on the fees pages of our website. The days 25-28 August 2026 are non-funded and will be charged at the Nursery's usual day rate.

A claim for FEE can be made from the term after a child's third birthday until the 1st term of their 5th birthday. Please note that this is only applicable up to the age of Reception class. If you would like your child to attend whole day sessions fees are payable in line with the schedule on the fees page of our website. You are, of course, able to indicate your preferred days and how many sessions you wish your child to attend each week. We will do our best to accommodate your preferences provided we have the available spaces and the necessary staff.

If you would like to access 12 hours FEE without incurring any charges you can do so between 3.00pm and 5.30pm Monday to Friday - the places will be subject to availability. If your child is only accessing the Free Early Education between the above-mentioned hours, there will be no registration fee or deposit and there will be no requirement to purchase school uniform or a school bag. The School's standard notice periods do not apply to Free Early Education, so there will be no fees in lieu of notice and we are unable to suspend or terminate the FEE.

At the start of the school term after your child's third birthday, you will be asked to complete and sign a Parental Declaration Form. This document will be available from the Nursery office during the first week of the months of September, January and April. Please ensure that you complete and sign this document, so that we can submit the claim for FEE on your behalf. In order to complete, the claim we will need to see your child's original birth certificate or passport. Therefore, please bring one of these documents to the school when you come to sign the form.
